The property is situated in All Saints Street at the estate known as All Saints Industrial Estate/ Hockley Port Business Centre.

# Description

A single storey Victorian industrial unit situated in a terrace of similar units being brick built with a slate roof and access doors to the front. The estate comprises of 18 units of varying sizes. The estate is located approximately 1/2 mile from the Jewellery Quarter within an old established inner city industrial area close to Middle Ring Road on edge of Handsworth.


